The Public Meeting of the Salisbury Township Board of Commissioners was held on the above date in the Township Municipal Building located at 2900 South Pike Avenue, Allentown, Lehigh County, Pennsylvania.

#### PLEDGE OF ALLEGIANCE

Commissioner Brown asked everyone to rise and recite the Pledge of Allegiance, followed by a short period of silence and reflection.

#### **CALL TO ORDER**

Commissioner Brown called the meeting to order at 7:00 p.m.

Commissioner Brown turned the proceedings over to Randy Soriano, Township Manager.

#### **NOTIFICATION**

Mr. Soriano informed the attendees that all sessions of the Salisbury Township Board of Commissioners regular meetings are recorded electronically for the purpose of taking the Minutes. All public comments on agenda items will be taken prior to the vote. All public comments related to non-agenda items will be taken after the agenda has been satisfied.

Mr. Soriano announced that the Township records the meetings and archives its tapes and records are available pursuant to the Right-to-Know Law, if requested.

Mr. Soriano reminded everyone of the three minute rule and asked that anyone who wishes to speak come to the podium, sign in, announce oneself, and speak clearly into the microphone. Mr. Soriano added that the speaker can choose not to list his/her address; however, it is preferred that the speaker announce if he or she is a Township resident. He noted that if a resident does not divulge his or her address, it will impair the Township administrative follow-ups on a particular issue.

#### APPROVAL OF FINANICAL REPORT AND BILLS PAYABLE

Mr. Soriano presented the unaudited Financial Report and the list of Bills Payable.

#### **MINUTES**

#### October 9, 2014

Commissioner Brown declared the October 9, 2014 Regular Meeting Minutes of the Board of Commissioners approved as presented.

#### **MOTIONS**

### Motion to approve the resignation of Sandra Thomas from the Environmental Advisory Council.

Mr. Soriano stated that Ms. Thomas represented Ward 1 and must resign due to personal reasons. He noted that Commissioner Martucci should appoint a new representative from that Ward.

It was the consensus of the Board to approve the Motion.

#### **ANNOUNCEMENTS**

Mr. Soriano stated that there will be two Ordinances up for vote at the next regular Board meeting. The first one is pursuant to a subdivision reviewed by the Planning Commission, which they have tabled pending the vacation of a portion of an unnamed alley that extends between Stanley Avenue and Salisbury Road. He stated that the minor subdivision will not go before the Board, but the Board must vacate the two streets that are requested by the applicant before the minor subdivision can be approved.

Mr. Soriano commented that the second Ordinance has to do with the adoption of a cafeteria plan of the Township employees, effective January 1, 2015. He stated that the plan will allow employees to receive health benefits without being subject to federal income taxes.

Mr. Soriano announced that DCNR has approved an application for a planning grant in the amount of \$26,500 for the preparation of a Master Site Plan for Laubach Park. He stated that DCNR also approved \$180,000 towards Phase II of the Lindberg Park Master Site Plan, which includes the inter-park trails connecting to the perimeter trails. Mr. Soriano thanked URDC for their help in the grant application process.

Mr. Soriano thanked Chief Stiles and Officer Bryan Losagio for their part in obtaining the official Resolution from the County for a Grant in the amount of \$130,305.

Mr. Soriano stated that the Collective Bargaining Agreement has been signed by the Public Works Department and Commissioner Brown will sign it tonight.

Mr. Soriano announced that the bid specifications for the Municipal Solid Waste and Recycling Services will be ready October 24<sup>th</sup>, 2014.

Mr. Soriano noted that he would like to convene into an Executive Session after the Workshop to discuss a possible property litigation issue.

#### **PRIVILEGE OF THE FLOOR**

Mr. Pablo Suarez of 1601 Lehigh Avenue expressed concerns about flooding issues on his property from runoff on the mountain and East Susquehanna Street. Mr. John Carlos of 1350 Lehigh Avenue was also present to discuss the situation and offer suggestions to remedy the condition. Mr. Suarez and Mr. Carlos presented the Board with pictures and a video. Commissioner Martucci stated that he is familiar with the circumstances in that area and inquired if the Township would be able to send Mr. Tettemer to do a study and/or offer recommendations.

A discussion ensued as to the best way to handle the situation. Mr. Soriano commented that the Township can assist Mr. Suarez in giving some ideas of what might or might not work; however, the property owner will ultimately be responsible for whatever work he decides to do. He suggested that Mr. Suarez work with his surrounding neighbors for the common good of trying to alleviate the water runoff, and recommended signing an agreement to protect both parties. Mr. Soriano also suggested that Commissioner Martucci write a letter to PennDOT and to the State Representative on behalf of the resident.

Mr. Tettemer opined that East Susquehanna Street is not really the problem. Instead, what has to be looked at is how to get the water from the pipe on East Susquehanna Street to Trout Creek. He stated that his recommendation is to have the issue looked at by a professional. Ms. Sopka noted that no permits will be required if excavating less than 5,000 sq. ft.

It was concluded that Ms. Sopka, Mr. Tettemer and Commissioner Martucci will visit the property to see if they can offer suggestions.

Commissioner Ackerman inquired if Mr. Tettemer will have the MS4 project completed for the Budget discussions. He commented that he is hopeful it will be completed shortly.

Chief Stiles stated that Officer Losagio observed traffic at Green Acres Drive and South Ott Street after Commissioner Ackerman expressed concerns about motorist failing to stop at the stop sign, but Officer Losagio did not see any issues while he was out there. Commissioner Ackerman thanked the Chief for sending officer Losagio to the location, and she commented that things have improved.

Chief Stiles commented that the Department conducted a six day study on South Dauphin Street after receiving complaints about speeding on that road. He noted that the speed limit is 25 mph and the average speed was 14.4 mph average cars per day was 279 cars.

#### **ADJOURNMENT**

Commissioner Martucci made a Motion to adjourn the Meeting, seconded by Commissioner Ackerman. The time was 8:20 p.m.

#### **ORDINANCE NO. 11-2014-591**

#### AN ORDINANCE OF SALISBURY TOWNSHIP, LEHIGH COUNTY, PENNSYLVANIA, VACATING A PORTION OF AN UNNAMED ALLEY EXTENDING BETWEEN STANLEY AVENUE AND SALISBURY ROAD

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Salisbury, Lehigh County, Pennsylvania, in lawful session, duly assembled as follows:

WHEREAS, the sole adjoining property owner has presented a petition and a written description of a certain alley extending between Stanley Avenue and Salisbury Road which was unnamed and unimproved; and

WHEREAS, said alley was never opened or improved; and

WHEREAS, the adjoining property owner has requested an affirmative vacation of a portion of said alley since said alley has not been opened for a period of twenty-one (21) years nor worked on by the Township for a period of twenty-one (21) years, although an affirmative vacation may not be necessary; and

WHEREAS, the Board of Commissioners is desirous of removing said unimproved street from the township maps and/or records; and

WHEREAS, it is in the interest of the public convenience to affirmatively vacate said street.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Salisbury, and it is hereby ordained and enacted by the authority of the same as follows:

<u>Section 1</u>. All "Whereas" clauses are incorporated herein by reference.

<u>Section 2</u>. The aforementioned alley is described in the attached description, which is attached and marked as Exhibit "B" and is approximately depicted on a plan attached and marked Exhibit "A".

Section 3. This Ordinance is passed in accordance with the Act of 1907, May 23 P. L. 223, No. 171 Section 1 53 P. S. 1941.

<u>Section 4</u>. This Ordinance shall become effective forty (40) days after the enactment hereof.
