1. Salisbury Township Storm water Basin Retrofit – work is dependent upon weather.

**New Business:**

1. MS4 Public Participation and Education
  - a. Status regarding completion of the worksheet provided by Kreg Ulery that covers Public Education and Public Involvement
  - b. Deadline for completion of the worksheet is listed as Wednesday, April 8<sup>th</sup>, 2015.
  - c. The Worksheet should be submitted to Kreg Ulery.

2. Preparation for the Clean-up of Walking Purchase Park scheduled for April 26<sup>th</sup>, 2015.
  - a. A flier was prepared by the Township
  - b. We have secured the upper parking lot of the Fearless Fire Company to park cars then get taxied to the work sites
  - c. Sandy, Cindy and Bob Agonis tagged sites along Constitution Drive where litter has been distributed. The complexity is most of the debris has worked it's way to the base of the mountain which is near the rail lines.
  - d. We have to schedule a day to evaluate the debris along Riverside Drive and the debris that may have been dumped toward the Lehigh River.
  - e. We need to assess the number of dumpsters that will be available and their placement.
  - f. There is a tremendous amount of electronics such as Televisions that have been dumped from Constitution Drive – we will need to evaluate who will assume the appropriate disposal of these televisions since electronics are not allowed in the traditional garbage stream.
3. EAC to start working on the educational and public participation plan for the MS4 program.
4. Stormwater Basin Retrofit:
  - a. Met with Director of Public Works to address some preliminary work on the storm water basin.
    - i. Removal of diseased trees
    - ii. Removal and securing the cattails for later planting
    - iii. Removal of gravel and soils that were deposited into the basin.
    - iv. Removal and destruction of invasive plants
