- 2. Salisbury Township is seeking a representative from the EAC to sit on the committee for the Laubach Park Master Site Plan. It will require several meetings typically held in the evening. If someone from the EAC is interested in participating with this opportunity please notify Cynthia Sopka.
- 3. Report regarding meeting Randy Dietrich at Walking Purchase Park entrance to evaluate the capacity of the cameras. Randy made a few recommendations such as the Township and the City to provide such as:
 - a. Provide 2 speed humps that are separated by 4 feet to allow time for the cameras to activate themselves and capture the pictures of vehicles passing through.
 - b. Provide Signage limiting the Speed Limit to 20 mph DRIVE WITH CAUTION HIKERS AND BIKERS ON ROAD
- 4. Recommendation is to provide parking stripes in the parking lot area
- 5. Create bat houses and wood duck housing as a means to camouflage the cameras throughout the area where most of the dumping is occurring.
