# Genny Baillie:

One counselor posed numerous issues throughout the program and will not be returning, while many other counselors, both new and returning, stepped-up and proved to be good leaders. ### **New Business:**

Finally, there are many branches down at Lindberg Park that have not been cleared all summer and the bridge at Laubach Park has been vandalized and needs repair and cleaning.
