Releaser hereby agrees to indemnify and save and hold harmless the Township, its officers, employees, and agents and each of them from any loss, liability, damage, costs or reasonable attorney fees that may be incurred while participating in the bus trip event, including, but not limited to, arrival and departure to and from Salisbury Township and West Chester and Kennett Square, late arrival at pickup locations, participation and activities at venues located within West Chester and Kennett Square, Pennsylvania such as the visit to Longwood Gardens and QVC Tour, and any drink, food, or retail establishments within Pennsylvania; and

Releaser hereby assumes full responsibility for any risk of bodily injury, death or property damage due to the negligence of Releaser during the participation in the bus trip event; and Releaser warrants and represents that he/she carries Medical and Liability Insurance for any personal injuries, and/or property damage or loss that may arise due to the negligence of Releaser during the bus trip event.
