Site is improved with a freestanding single story $\pm 6,200$ square foot main office/shop building, a freestanding single-story $\pm 4,457$ square foot office/sop building identified as the trolley barn, and a freestanding single-story $\pm 1,968$ square foot two-unit apartment building. In addition, the subject property contains a 42' x 100' or $\pm 4,200$ square foot Quonset hut; however, it is a non-permanent structure with a substantial hole in the roof covering and *not* considered part of the real estate, but is included in the sale of the real property. The site is also improved with gravel and macadam, which provide additional exterior landscape product and vehicle/equipment storage yard areas. The three (3) tax parcels identified as 100 Mountain Park Road, 145 East Rock Road, and 155 East Rock Road consist of ± 30.6949 -acres, which are currently enrolled in ACT-319, a preferential tax program; however, approximately 4.0-acres are currently utilized in conjunction with the neighboring commercial use as an existing non-conforming/grandfathered use.
