All owners of any residential rental property located within the Township of Salisbury will be billed annually for the rental registration.

It is the owners responsibility to notify the Township if the property is sold or no longer a rental within the Township.

INSPECTION SCHEDULING

- 1. The property owner/landlord must schedule an inspection when setting up a property as a rental and prior to a new tenant moving in.
- 2. Fee for inspection: The inspection fee is a fifty-dollar (\$50.00) flat fee which will cover an initial inspection. The rental inspection fee is due at the time of the scheduled inspection.
- 3. Fee for additional re-inspections: Any additional re-inspections are subject to an additional fee of twenty-five dollars (\$25.00) per re-inspection until code compliance is achieved.

- 5. All tenants must complete a Moving Permit prior to moving in, moving out, or moving within the Township.

It is understood and agreed upon by this Applicant that any misstatement or misrepresentation of material fact, either with or without intention on the part of this Applicant, such as might or would operate to cause refusal of this application, shall constitute sufficient grounds for the revocation of this registration.

Any person, firm or corporation who or which violates the provisions of Ordinance (No. 11-2018-619) shall be subject to the following penalties

- a. First Violation: A fine up to \$300.00, or thirty (30) days imprisonment, or both.
- b. Second Violation: A fine up to \$500.00, or sixty (60) days imprisonment, or both.
- c. Third & Each Subsequent Violation: A fine up to \$1,000.00, or ninety (90) days imprisonment, or both.
