March 27, 2025

Commissioner Brinton declared the Minutes from March 27, 2025 accepted as presented.

NEW BUSINESS

ORDINANCES

Ordinance Establishing a Sewer Lateral Inspection and Repair Program.

Commissioner Brinton explained that this Ordinance adopts regulations to require the testing, inspection, repair, and replacement of sewers and sewer laterals for certain structures in the Township, including existing non-residential buildings and upon the resale of residential buildings, and providing for remedies and penalties for non-compliance.

Mr. Nicolo stated that this was discussed in a workshop, but since then, language has been added to allow for time extension requests, hardship deferrals, exemptions, and waivers.

Motion by Commissioner Conn, seconded by Commissioner Karol, to adopt Ordinance No. 04-2025-674, establishing a Sewer Lateral Inspection and Repair Program.

The Board voted: 5 Ayes; 0 Nays.

RESOLUTIONS

Resolution Recognizing the Years of Service and Accepting the Retirement of Township Manager Cathy Bonaskiewich.

The Board thanked Ms. Bonaskiewich for her 40 years of service to the Township.

Motion by Commissioner Patnaik, seconded by Commissioner Conn, to adopt Resolution No. 04-2025-1852, recognizing the Years of Service and Accepting the Retirement of Township Manager Cathy Bonaskiewich.

The Board voted: 5 Ayes; 0 Nays.

Resolution Appointing New Township Manager Cathy Gorman, effective April 28, 2025.

Motion by Commissioner Lipkin, seconded by Commissioner Karol, to adopt Resolution No. 04-2025-1853, appointing new Township Manager Cathy Gorman, effective April 28, 2025.

The Board voted: 5 Ayes; 0 Nays.

Resolution Authorizing the Disposal of Township Vehicles and Equipment.

Commissioner Brinton stated that the Township has Police, Public Works and Animal Control vehicles to dispose of by way of online auction sale, along with a boom mower, generator and gas boiler.

Motion by Commissioner Conn, seconded by Commissioner Patnaik, to adopt Resolution No. 04-2025-1854, authorizing the disposal of Township vehicles and equipment.

The Board voted: 5 Ayes; 0 Nays.

MOTIONS

Motion Awarding Road Equipment Rental with Operators Bid to Bracalente Construction.

Mr. Myers explained that there were inconsistencies in the bid documents submitted by the apparent low bidder, leading to the rejection of that bid. As a result, they are recommending awarding the contract to the second lowest bidder, Bracalente Construction.

Motion by Commissioner Conn, seconded by Commissioner Lipkin, to award the Road Equipment Rental with Operators Bid to Bracalente Construction.

The Board voted: 5 Ayes; 0 Nays.

Motion Rescinding Township Policy #400.3 – Street Plowing and Cidering Policy.

Commissioner Brinton noted that this is the first step in efforts to properly address the parameters concerning the Township's responsibilities for maintenance and repair of certain non-publicly owned and/or adopted streets and alleys. She stated that the Township has been taking care of these roads, but because they are in poor condition, it becomes problematic for Township equipment.

Motion by Commissioner Karol, seconded by Commissioner Conn, to rescind Township Policy #400.3 – Street Plowing and Cindering Policy.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Ceasing of Planning Commission Notification Mailings and Advertising.

Commissioner Brinton noted that this topic has been discussed at previous meetings and commented that anyone interested in viewing a Planning Commission agenda, including detailed project information, can do so by visiting the Township's website

Commissioner Karol clarified that this only pertains to planning matters, not zoning.

Motion by Commissioner Karol, seconded by Commissioner Lipkin, to authorize the ceasing of Planning Commission notifications mailings and advertisements.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Engagement of Consultant Strategic Solutions, LLC to Conduct Comprehensive Plan Update.

Mr. Nicolo stated that the Municipal Planning Code requires Comprehensive Plan updates every ten years, and since the Township's current Plan was last updated in 2012, an update is now overdue.

Commissioner Karol noted that the amount will not exceed \$75,000. Mr. Ziegenfus commented that they worked together to incorporate it into the budget as a multi-phase, multi-year project.

Motion by Commissioner Patnaik, seconded by Commissioner Lipkin, to authorize the engagement of Consultant Strategic Solutions, LLC to conduct a Comprehensive Plan update.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Entering into a Permanent Traffic Signal Easement Agreement and a Pedestrian Easement Agreement with Nicholas Park Mall LLC.

Ms. Bonaskiewich stated that this request was made by the attorneys for the developers of the South Mall for their redevelopment efforts. She noted that the easements will allow for the construction and maintenance of the required traffic signal supports as well as provide for the

construction of the required pedestrian path along the properties located at 3152 and 3310 Lehigh Street.

Attorney Gross commented that the document is routine and it is a safety issue.

Motion by Commissioner Conn, seconded by Commissioner Patnaik, to authorize entering into a Permanent Traffic Signal easement agreement and a pedestrian easement agreement with the Nicholas Park Mall, LLC.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Entering into a Permanent Traffic Signal Easement Agreement with SAR Associates, LLC.

Ms. Bonaskiewich noted that this easement agreement is the same as the prior one, but across the street.

Motion by Commissioner Conn, seconded by Commissioner Karol, to authorize entering into a Permanent Traffic Signal Easement Agreement with SAR Associates LLC.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Land Lease Agreement with Kriger Construction.

Commissioner Karol explained that the company is working on local construction projects and is using the McAuliffe property to stage vehicles, equipment, and materials, while compensating the Township for the use of the space.

Motion by Commissioner Karol, seconded by Commissioner Lipkin, to authorize the Land Lease Agreement with Kriger Construction.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Land Lease Agreement with JD Eckman Inc.

Motion by Commissioner Karol, seconded by Commissioner Lipkin, to authorize the Land Lease Agreement with JD Eckman, Inc.

The Board voted: 5 Ayes; 0 Nays.

Motion Authorizing Renewal of Franko Lease Agreement.

Commissioner Brinton commented that Mrs. Valentine Durner has been the Township's solo tenant since December 2017 and has maintained the property beautifully. She noted that the term of the lease will run from June 1, 2025 through May 31, 2026.

Motion by Commissioner Lipkin, seconded by Commissioner Patnaik, to authorize the renewals of the Franko Lease Agreement.

The Board voted: 5 Ayes; 0 Nays.

Chief Sabo invited the Board to the Police Department on May 9th at 9:30 a.m. for 'Coffee with Constituents' with Senator Nick Miller and his staff, followed by the grand opening of the EOC and training room. He also reminded the Board that Senator Miller played a key role in securing grant funding for the Police Department renovations.

Chief Sabo stated that officers have been doing aggressive driving grant work. He urged the public to report any complaints about certain areas so he can pass along the concerns to the traffic unit.

Mr. Levernier reported that all parks have been mulched and that the old playground equipment at Lindberg Park has been removed in preparation for the installation of new equipment.

Mr. Levernier also noted that 35 new street trees have been delivered and are scheduled to be planted next week.

Mr. Levernier commented that he spoke with Bracalente Construction and they are hoping to start paving on Country Club Road later this month.

Chief Sabo reported that the traffic unit followed up on concerns in the Overhill Road area. Over a two-hour period, they recorded the highest speed at 37 mph, the lowest at 10 mph, with an average speed of 23.65 mph and a median speed of 25 mph. He added that they will continue to include the area in their enforcement efforts.

Commission Lipkin reminded the Board about the upcoming EAC meeting on April 16.

Commissioner Patnaik brought forth a question from a resident about the Township's plan for forest management. Mr. Levernier commented that he has a forest management plan for Franko and Walking Purchase Park as well as the McAuliffe property, and invited the Commissioners to review it. He noted that the forester assessed the properties last fall, and there is the option to follow through with the plan. He stated that he will email the report from the forester to the commissioners for review.

Commissioner Patnaik inquired about the possibility of installing flashing stop signs at all intersections. Mr. Levernier explained that these signs cost \$2,500 each, compared to \$45 for a

regular stop sign. As a result, only certain intersections have been selected for flashing signs. He also noted that a new policy requires PennDOT approval before installation. Mr. Levernier stated that he and the Chief typically evaluate the intersections and install two flashing signs per year. Chief Sabo added that they have started applying reflective tape down the front of the poles for better visibility.

Mr. Myers stated that the Act537 Plan should be delivered to the Planning Commissioner next week, which starts the final chapter in getting it approved.

Mr. Ziegenfus commented that the audit is complete and he will present the draft at the next workshop. He noted that the auditor will present the report at a meeting in May.

Mr. Jerry Royer of Western Salisbury Volunteer Fire Company provided the Board with an update on the new fire station. He stated that they are currently conducting classes for new firefighters in the area and noted that they have five new firefighters at their station.

Mr. John Kelly of Western Salisbury Volunteer Fire Company provided a financial update on the new fire station. He thanked the residents, businesses and the Township for their financial support.

Ms. Bonaskiewich inquired about any progress regarding the use of the new fire station as a polling station. Mr. Kelly stated that he has not received any updates, so Ms. Bonaskiewich will follow up with the County. Commissioner Brinton mentioned that residents had approached her about having a polling location for Ward 5-2 within the Township, as the current polling location is in the City of Allentown.

Mr. Dennis Engle of 969 Bridle Path Road noted that, as a poll worker, he often sees confusion among residents in Ward 5-2 about where they are supposed to vote

Ms. Cathy Gorman thanked the Board for the opportunity and expressed her eagerness to work with everyone and assist the residents of the Township.

ADJOURNMENT

Commissioner Patnaik made a motion to adjourn the meeting. Commissioner Lipkin seconded the motion. The time was 7:53 pm.

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE
TOWNSHIP OF SALISBURY, LEHIGH COUNTY, PENNSYLVANIA
APPROVING THE TRANSFER OF RESTAURANT LIQUOR LICENSE
NO. R-982 INTO THE TOWNSHIP OF SALISBURY FOR USE BY THE
GIANT COMPANY, LLC**

WHEREAS, Act 141 of 2000 ("the Act") authorizes the Pennsylvania Liquor Control Board ("PLCB") to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the Act requires the applicant obtain from the receiving municipality a resolution or ordinance approving the inter-municipal transfer of the liquor license prior to the applicant's submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a resolution or ordinance by the receiving municipality, at least one public hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding the applicant's intent to transfer a liquor license into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, that The Giant Company, LLC (hereinafter, "Applicant") has requested the approval of the Board of Commissioners of Salisbury Township for the proposed transfer of Pennsylvania Restaurant Liquor License No. R982 from The Giant Company, LLC at an address of 3015 W Emmaus Avenue, Allentown, PA 18103-7107 to a new store located at 3300 Lehigh Street, Allentown, PA 18103 with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of Salisbury Township have held a public hearing pursuant to duly advertised public notice in accordance with the requirements of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer by the Applicant impacting the above stated location; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of Salisbury Township approves, by adoption of this Resolution, the proposed inter-municipal liquor license transfer of Pennsylvania Restaurant Liquor License No. R-982 to the Applicant; and

BE IT FURTHER RESOLVED, that transfers, designations and assignments of liquor licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.
