Minor Subdivision No. 58250011 Review of minor subdivision project at 1763 Broadway submitted by Green Hammer Properties, LLC which proposes to subdivide the property into three lots and develop a single-family, detached dwelling on Lot #1 and semi-detached (twin) units on Lot #s 2 and 3 along with all required infrastructure and site improvements. The overall lot size is 18,750 square feet; Lot #1 will contain 8,750 square feet and Lot #s 2 and 3 will each contain 5,000 square feet. All will have frontage along Broadway. The property is within the R4, Medium Density Residential zoning district and is currently vacant land.
- 8. <u>Land Development No. 58250001</u> Review of the land development project at <u>1030</u> <u>East Emmaus Avenue</u>, <u>1108 East Emmaus Avenue</u>, and <u>1210 East Emmaus Avenue</u> submitted by Vistas at South Mountain Holdings, LLC which proposes to consolidate three lots into two and develop 88 townhomes on Lot #1 and a single-family detached dwelling on Lot #2 along with all required infrastructure and site improvements. The overall lot size is 48.5197 acres; Lot #1 will contain 46.7965 acres of land with frontage along East Emmaus Avenue, Lot #2 will contain 1.1903 acres

of land with frontage along Honeysuckle Road, 0.1421 acre will be dedicated as right-of-way along Honeysuckle Road, and 0.3909 acre will be dedicated as right-of-way along East Emmaus Avenue. The property is within the R3, Medium Low Density Residential and the CR, Conservation-Residential zoning districts and is currently vacant land. All dwelling units will be within the R3 zoning district boundaries.
